### What are the adoption statistics?

\n

- $\bullet$  Between 2010 and 2017, adoptions have gone down drastically. \n
- While 5,693 children were adopted within India in 2010, the 2016-17 figures were only 3,210.

۱n

- Even adoptions from outside fell from 628 in 2010 to 578 currently.
- The fall has been attributed to tightened norms to protect the adopted children.

• Despite the safeguards though, not all adoptive children stay safe.

# Who do the present Indian guidelines in say?

• Adopting parents must be financially capable, physically, mentally and emotionally stable.

\n

 $\bullet$  They should also be free from life threatening health conditions. \n  While singles less than 55 years of age too are eligible for adopting, a single male cannot adopt a girl child.

- A couple must be married at least two years and their cumulative age at the time of adoption cannot exceed 110 years.
- $\bullet$  The minimum age difference between the child and either adoptive parent should not be less than 25 years.  $\mbox{\sc h}$
- Preference shall be given to place the child in adoption in his/her own sociocultural environment, as far as possible.

# What is the procedure for adoption by overseas residents?

• All prospective parents irrespective of nationality have to register with the Central Adoption Resource Authority (CARA).

۱n

- Then, the appropriate local authorities are called for a home study.
- Subsequently, registration with the 'Child Adoption Resource Information and Guidance System' is done.

- After registration, children are assigned by turn, and foreign couples are treated at par with Indian ones.
- Countries that are signatories to the 'Hague Adoption Convention' have standardised and streamlined such processes.
- Alternatively, the Indian diplomatic missions in the respective countries can also be approached.

#### How is the match done?

 $\bullet$  The home study report, which looks at the couple's family, circumstances etc.., is prepared by the adoption agency.  $\mbox{\ensuremath{\backslash}} n$   It remains valid for two years, and is the basis of any adoption attempts that the couple make during that period.

\n

- Parents are given a chance to adopt on a first registered, first served basis.
- Photographs, child study reports and medical examination reports of up to six children in their preferred category are shown.
- The process of matching must be completed in 15 days.

### When is a child eligible to be adopted?

• A child has to be declared legally free to be adopted before being shown to a couple for adoption.

۱n

• If an unclaimed child is found, the 'District Child Protection Unit' has to advertise the particulars and photograph in a state-level newspaper with wide circulation within 72 hours.

• Local police have to submit a report about the child's parents or any living family.

 $\bullet$  Subsequently, if there isn't any response 'Child Welfare Committee' can declare the child legally free for adoption. \n

# What legal process has to be followed?

- The adoption petition is filed in court by the adoption agency and the proceedings are to be completed within two hearings.
- The petition has to be disposed within two months of its filing and the certified copy of the order has to be obtained within 10 days.
- Obtaining the birth certificate of the child with the names of the adoptive parents also has to be done.
