Cross LoC trade across Uri-Muzaffarabad route resumed this week after it was stopped over 2 weeks ago due to seizure of drugs form a truck.

### What is the significance of Cross LOC Trade?

- To ease tensions between India & Pakistan, to promote peace & economic activity in the state of J&K, cross-LoC trade was started in 2008.  $\n$
- Through not very voluminous in nature, it helped connect the regions of J&K on both sides of the border.

- The trade is through barter exchange & has by far has been a successful initiative.

- The present ruling party of J&K, had promised to support this trade.  $\space{\space{1.5}n}$
- With increasing border tensions, trade across the Poonch-Rawalakot route has been stopped since July.  $\nline{1}$
- The Uri-Muzaffarabad route was also suspended following the recovery of Rs 300 crore worth heroin and brown sugar from a truck coming from PoK.

# What are some recent developments concerning cross LoC trade?

- The National Investigation Agency (NIA) began probing the funding patterns of traders due to numerous allegations.  $\gamman{\cap{N}}{\lambda}$
- A joint meeting between officials of both sides was held.  $\space{\space{1.5}n}$
- It was decided that permanent and formalised communication facilities will be set up between the respective trade officers.  $\n$
- A number of steps have been proposed that could lead to a change in the trading mechanism, based on the ongoing research of Bureau of Research on Industry and Economic Fundamentals (BRIEF).

### What are some steps to better this trade?

- Joint Investigation Teams should be set up to investigate cases of narcotic and arms smuggling across the border.
- They should address the root cause of such instances in a speedy and transparent manner and help prevent the victimisation of truck dirvers in future.

• **Trade Monitoring Cells** should be constituted to keep a check on the traders and trade practices,.

• It should monitor daily trade practices such as registration of traders, invoicing and exchange of goods, trade balancing, etc. to address allegations of hawala money, under-invoicing, and even misrepresentation of goods.

- Trade data and information for each registered trader should be mandatorily recorded in an electronic format and shared with the cell at regular intervals for analysis and other checks.  $\n$
- Institutionalisation Traders and chambers on both sides have come up with the idea of a joint chamber, which will have traders of both sides as well as the local chambers of Jammu and Kashmir and the Mirpur

Chamber.

- Support from both governments will help create more transparency in transactions and information flow among traders and chambers on across the LoC & within.

- **Training** It is important to impart training to LoC traders, with support from excise and security agencies.
- Training sessions should be conducted on the standard operating procedures of this trade as well as established accounting practices such as maintaining balance sheets.
