A trade deficit is an economic measure of international trade in which a country's imports exceeds its exports.

Trade Deficit = Total Value of Imports - Total Value of Exports

When a country runs a trade deficit, it is important to see whether there has been a decrease in saving, increase in investment or an increase in the budget deficit. There is reason to worry about a country's long-run prospects, if the trade deficit reflects smaller saving or a larger budget deficit (when the economy has both trade deficit and budget deficit, it is said to be facing twin deficits. The deficit could reflect higher private or government consumption.
