- He along with Srinivasa Iyengar and Subhash Chandra Bose founded the Independence for India League in the year 1928 which put forth the demand for complete independence.
- Srinivasa Iyengar was its first president.
- Indian Independence League was a political organisation operated from the 1920s to the 1940s to organise those living outside India into seeking the removal of British colonial rule over India
- It was established by various Indian nationals and was located in several parts of Southeast Asia
- 3. Consider the following statements regarding 'Dhanush'
 - 1. It is India's first indigenous, long-range artillery gun which was recently cleared for induction into the Army
 - 2. Its range is 11 km more than that of the Bofors guns, based on whose design Dhanush was developed

- India's first indigenous, long-range artillery gun "Dhanush" has passed its final test at Pokhran, paving the way for its induction into the Army
- Dhanush is a 155mm x 45mm calibre artillery gun and is also called the "desi Bofors".
- It has a strike range of 38 kilometres and 81 per cent of its components are indigenously sourced

 Currently a shift from base rate to MCLR for loan payments mandate a fee to be paid by bank
- Though RBI had said it would link the base rate to MCLR from April, 2018 for loans dated before April, 2016, it has still not come into effect
- The MCLR is more sensitive to monetary policy transmission and is closely linked to the actual deposit rates.

- Following this a plethora of cases the right to information was recognized as a right implicit in the article 19(1)(a) and in article 21 (right to life and personal liberty).
