• With a view to promoting innovation and enterprise among SC students studying in higher educational institutions, Ministry of Social Justice and Empowerment has recently launched the "Ambedkar Social Innovation and Incubation Mission (ASIIM) under Venture Capital Fund for SCs"



# Ambedkar Social Innovation and Incubation Mission (ASIIM)

### **Objectives**

- To promote entrepreneurship among the SC Youth with special preference to Divyangs.
- To support (1,000) innovative ideas till 2024 through a synergetic work with the Technology Business Incubators (TBIs) set up by Department of Science and Technology.
- To support, promote, hand-hold the start-up ideas till they reach commercial stage by providing liberal equity support.
- To incentivise students with innovative mindset to take to entrepreneurship with confidence.

# Working

- They will be funded Rs. 30 lakhs in 3 years as equity funding so that they can translate their start-up ideas into commercial ventures.
- Successful ventures would further qualify for venture funding of up to Rs. 5 Crore from the Venture Capital Fund for SCs.

#### 2. d

- BrahMos surface-to-surface supersonic cruise missile featuring indigenous Booster and Airframe Section along with many other 'Made in India' sub-systems was successfully flight tested recently from ITR, Balasore in Odisha.
- It is one more major step in enhancing the indigenous content.
- The BrahMos Land-Attack Cruise Missile (LACM) was cruising at a top speed of Mach 2.8.

#### **BRAHMOS**

- It is a universal long range supersonic cruise missile system that can be launched from *land*, *sea and air*.
- It has been jointly developed by **DRDO**, **India**, **and NPO Mashinostroeyenia** (**NPOM**), **Russia**.
- BrahMos is a *two-stage missile* with a solid propellant booster engine as its first stage which brings it to supersonic speed and then gets separated.

• The liquid ramjet or the second stage then takes the missile closer to Mach 3 or three times the speed of sound in cruise phase.

#### 3. b

### Missile Technology Control Regime (MTCR)

- It is an *informal political understanding* among states that seek to limit the proliferation of missiles and missile technology.
- The regime was formed in 1987 by the *G-7* industrialized countries (Canada, France, Germany, Italy, Japan, the UK, and the United States).
- There are currently 35 countries that are members (Partners) of the MTCR.
- India is one among the 35 members (Joined in 2016).
- There is no formal linkage between the MTCR and the United Nations (UN).
- The MTCR is not a treaty and does not impose any legally binding obligations on Partners (members).
- The MTCR seeks to limit the risks of proliferation of weapons of mass destruction (WMD) by controlling exports of goods and technologies that could make a contribution to delivery systems (other than manned aircraft) for such weapons.
- In this context, the Regime places particular focus on rockets and unmanned aerial vehicles capable of delivering a payload of at least 500 kg to a range of at least 300 km and on equipment, software, and technology for such systems.

#### 4. b

- Yakshagana is a traditional folk dance form popular in coastal districts of Karnataka and northern area of Kasaragod district of Kerala.
- It is a rare combination of dance, music, song, scholarly dialogues and colourful costumes.
- A celestial world unfolds before the audience, as loud singing and drumming form a backdrop to dancers clad in striking costumes.



- Hence the name Yaksha (celestial) Gana (music).
- This is a night-long event, with elaborately adorned performers dancing to the beat of drums in open-air theatres – usually in the village paddy fields after the winter crop has been harvested.
- Traditionally, men portray all roles, including the female ones, though women are now part of Yakshagana troupes.
- A typical troupe consists of 15 to 20 actors and a Bhagavatha, who is the master of ceremonies and the main storyteller.
- The performances draw crowds from far and wide, with a fair-ground atmosphere pervading the venue till dawn.
- Each performance typically focuses on a small sub-story (known as '*Prasanga*') from ancient Hindu epics of Ramayana or Mahabharata.
- The show consists of both stage performances by talented artists and commentary (performed by the lead singer or Bhagavatha) accompanied by traditional music.
- Musical instruments used in Yakshagana include Chande (drums), Harmonium, Maddale, Taala (mini metal clappers) and flute among others.

- Positive Pay System for Cheque Payments to come into effect from January 1, 2021, according to the RBI.
- Positive pay is an automated cashmanagement service employed to deter check fraud.
- It is offered by most commercial banks to companies to protect them against forged, altered, and counterfeit checks.
- The system acts as a form of insurance for a company against fraud, losses, and other liabilities.

• Recently, the Palghar administration in Maharashtra on alert against a possible spread of the *Congo Fever*.

- The Crimean-Congo Haemorrhagic Fever (CCHF) is a viral haemorrhagic fever usually transmitted by ticks.
- It can also be contracted through contact with viraemic animal tissues.
- It can also be transmitted from one infected human to another by contact with infectious blood or body fluids.
- General supportive care with treatment of symptoms is the main approach to managing Congo fever (CCHF) in people.

- Defence Ministry released its latest *Defence Acquisition Procedure 2020 (DAP 2020)*.
- The new Defence Acquisition Procedure removes the clause for offsets for certain kinds of defence contracts.
- Defence Offsets are arrangements in which the importing country obliges the supplying company of the exporting country to reinvest some proportion of the contract in the importing country.
- These provisions will not apply to procurements under the Fast Track procedure.
- It does not apply also to procurements under the *Option clause* where an offset obligation was not stipulated in original contract.

- The Global Counter Terrorism Forum (GCTF) is an informal, a-political, multilateral counterterrorism platform.
- It is to strengthened the international architecture for addressing 21st century terrorism.
- One of the important goals of the forum is to support and catalyze implementation of the UN Global Counter-Terrorism Strategy.
- It is an international forum of 29 countries and the EU.
- It's mission is of reducing the vulnerability of people worldwide to terrorism by preventing, combating, and prosecuting terrorist acts and countering incitement and recruitment to terrorism.



• India is a member to this forum.

# Venture Capital Fund for SCs (VCF-SC)

- With a view to developing entrepreneurship amongst the SC/Divyang youth and to enable them to become 'job-givers', Ministry of Social Justice, Government of India had launched the Venture Capital Fund for SCs (VCF-SC) in 2014-15.
- The Objective of this fund is to provide concessional finance to the entities of the SC entrepreneurs.
- Under this fund, around 118 companies promoted by SC entrepreneurs have been sanctioned financial assistance to set up business ventures.

 Union Minister for Tribal Affairs will virtually launch India's largest handicraft and organic products marketplace, **Tribes** India E-Marketplace on the occasion of Gandhi Jayanti (October 2, 2020).

### Tribes India E-Marketplace

- It is an initiative keeping in line with the vision of the Prime Minister of making India, Aatmanirbhar and self-reliant.
- It is a path-breaking initiative of TRIFED under Ministry of Tribal Affairs.
- It will showcase the produce and handicrafts of tribal enterprises from across the country and help them market their produce/ products directly.
- It is a major leap towards the Digitisation of Tribal Commerce.

• Union Minister for Tribal Affairs will launch **Pakur Honey** by TRIFED & Tribes India on the occasion of Gandhi Jayanti (October 2, 2020).

### Pakur Honey

- It is 100% natural honey which is multi floral, forest fresh, gathered by Santhal Tribals and Vulnerable Pahadhiya tribes from Pakur, Jharkhand.
- Natural Multiflora honey is a good source of anti-oxidants and antiseptic vitamins, nutrients, enzymes and other herbal properties that no other super-food can provide.

#### **Paharias**

• In Jharkhand, there are two types of Paharias.

# Mal Paharia

• They live in the southern hills of Damin-i-koh and in the south and east of Santhal Parganas.

- A few of them are also found in Odisha, Bihar and West Bengal.
- They are listed as Scheduled Tribes in the states of Bihar, Jharkhand and West Bengal.
- The total population of Mal Paharias is expected to be just over 1 lakh.

### Shauria Paharia (Maler Paharia)

- They are mostly found in Santhal Parganas.
- The total population of Sauria Paharias is expected to be around 30,000.
- They are listed as Scheduled Tribes in the states of Bihar, Jharkhand and West Bengal.
- Their own language is "Malto".
- Mainly due to residence on mountain they are called as "*Pahadiya*".
- Their main source of livelihood has been shifting cultivation.

- Following the 146th WHO Executive Board's recommendation made in February 2020, the 73rd World Health Assembly, held on 3 August 2020, have endorsed the proposal for a Decade of Healthy Ageing (2020-2030) through written silence procedures.
- Member States have asked the Director-General to report back on progress on its implementation every 3 years during the Decade.
- The Health Assembly also asked the Director-General to transmit this decision to the Secretary-General of the United Nations for consideration of the proposal for the Decade by the United Nations General Assembly.

# Decade of Healthy Ageing (2020-2030)

• It is an opportunity to bring together governments, civil society, international agencies, professionals, academia, the media, and the private sector for ten years of concerted, catalytic and collaborative action to improve the lives of older people, their families, and the communities in which they live.

• Prime Minister Shri Narendra Modi will inaugurate **Atal Tunnel**, **Rohtang** on 3rd October 2020.

#### **Atal Tunnel**

- It is the longest highway tunnel in the World.
- It is a horse shoe shaped, single tube double lane tunnel.
- The 9.02 Km long tunnel connects Manali to Lahaul-Spiti valley throughout the year.
- Earlier the valley was cut off for about 6 months each year owing to heavy snowfall.
- The Tunnel is built with ultra-modern specifications in the *Pir Panjal range of Himalayas* at an altitude of 3000 Mtrs (10,000 Feet) from the Mean Sea Level (MSL).
- The tunnel reduces the road distance by 46 Kms between Manali and Leh and the time by about 4 to 5 hours.
- The South Portal (SP) of Atal Tunnel is located at a distance of 25 Km from Manali, while the North Portal (NP) of the tunnel is located near village Teling, Sissu, in Lahaul Valley.
- It is 10.5-metre wide and has fire proof emergency egress tunnel built into the main tunnel itself.
- It has the state of the art electromechanical system including semi transverse ventilation system, SCADA controlled firefighting, illumination and monitoring system.

### Background

- The historic decision to construct a strategic tunnel below the Rohtang Pass was taken on June 03, 2000 when late Shri Atal Bihari Vajpayee was the Prime Minister.
- The foundation stone for the Access Road to the South Portal of the tunnel was laid on May 26, 2002.

NITI Aayog, Ministry of New and Renewable Energy and Invest India are organizing a alobal symposium 'India PV EDGE 2020' virtually, on October 6, 2020.

### India PV EDGE 2020

- PVIt aims to catalyze cutting-edge manufacturing in India.
- There will be a plenary session and subsequent sessions on 'Wafers and Cells', 'Modules and Production Equipment' and 'Supply Chain'.
- It will also include a 'Investors Conclave' on PV Manufacturing.
- Tamil Nadu, Maharashtra and Andhra Pradesh states will participate in the conclave.

# India and Solar Energy

- India has become the third-largest solar capacity country in the world and set an ambitious target of 450 GW of renewable capacity by 2030, comprising 300 GW of solar capacity.
- India's NDC document of the Paris Agreement in 2015 called for extraordinary vision. leadership, compassion, and wisdom to combat climate change.
- India PV EDGE 2020 is one small step towards that ambition.

- Scientists from Agharkar Research Institute (ARI), Pune, an autonomous institute of the Department of Science & Technology, Government of India, have recently found two new species of pipeworts in Western Ghats.
- They found the new species in Maharashtra and Karnataka while exploring the biodiversity of the Western Ghats.
- The plant group known as pipeworts (Eriocaulon), which completes their life cycle within a small period during monsoon, exhibits great diversity in the Western Ghats, having around 111 species in India.
- Most of these are reported from the Western Ghats and Eastern Himalayas, and around 70% of them are endemic to the country.

### Some of the species are:

- 1. Eriocaulon cinereum, is well known for its anti-cancerous, analgesic, anti-inflammatory, and astringent properties.
- E. quinquangulare is used against liver diseases.
- E. madayiparense is an anti-bacterial from Kerala.
- The medicinal properties of the newly discovered species are yet to be explored.
- Western Ghats is one of the thirty-five hotspots of biological diversity in the world.

A historic Memorandum of Understanding (MoU) will be signed on 06 October, 2020, between Indian Sign Language Research and Training Center (ISLRTC) and NCERT (a National Institute of Ministry of Education) to make education materials accessible for Deaf children in their preferred format of communication viz Indian Sign Language.

## Indian Sign Language Research and Training Centre (ISLRTC)

- It is an autonomous national institute of Department of Empowerment of Persons with Disabilities in the Ministry of Social Justice & Empowerment.
- It is dedicated to the task of developing manpower for popularizing the use of Indian Sign



Language, teaching and conducting research in Indian Sign Language.

- The Comptroller and Auditor General (CAG) of India, in its latest audit report of government accounts, has observed that the Union government withheld in the Consolidated Fund of India (CFI) more than Rs. 1.1 lakh crore out of the almost Rs. 2.75 lakh crore collected through various cesses in 2018-19.
- The CAG found this objectionable since cess collections are supposed to be transferred to specified Reserve Funds that Parliament has approved for each of these levies.
- The nation's highest auditor also found that over Rs. 1.24 lakh crore collected as Cess on Crude Oil over the last decade had not been transferred to the designated Reserve Fund the Oil Industry Development Board — and had instead been retained in the Centre's coffers.
- Similarly, the CAG has also found that the Union government in the very first two years of the GST implementation wrongly retained Rs. 47,272 crore of GST compensation cess that was meant to be used specifically to compensate states for loss of revenue.

### TAX Vs CESS

- The Union government is empowered to raise revenue through a gamut of levies, including taxes (both direct and indirect), surcharges, fees and cess.
- Direct taxes, including income tax, and indirect taxes such as GST are taxes where the revenue received can be spent by the government for any public purpose in any manner it deems appropriate for the nation's good.
- In contrary, a cess is an earmarked tax that is collected for a specific purpose and ought to be spent only for that.
- Every cess is collected after Parliament has authorised its creation through an enabling legislation that specifies the purpose for which the funds are being raised.

# Supersonic Missile Assisted Release of Torpedo (SMART)

- SMART is a missile assisted release of lightweight Anti-Submarine Torpedo System for Anti-Submarine Warfare (ASW) operations far beyond Torpedo range.
- It is an indigenous missile system developed by the Defence Research and Development Organization (DRDO).

### Working

- SMART, when launched from warship or a truck-based coastal battery, takes off like a regular supersonic missile.
- It covers most of its flight in the air at lower altitudes with two-way data link from the warship or an airborne submarine target detection system and provides the exact location of the hostile submarine to correct its flight path midway.
- Just when it approaches close enough to the submerged submarine, the missile will eject the torpedo system into the water and the autonomous torpedo will start moving towards its target to take out the submarine.

- The Union Cabinet, chaired by the Prime Minister, has recently ratified the ban of seven Persistent Organic Pollutants (POP's) listed under Stockholm Convention.
- With the decision, India is sending out a positive message to the world that it is active in this area & do not tolerate health & environmental hazard.

### Stockholm Convention

- It is a global treaty to protect human health and environment from Persistent Organic Pollutants (POPs), which are identified chemical substances that persist in the environment, bio-accumulate in living organisms, adversely affect human health/environment and have the property of longrange environmental transport (LRET).
- India had ratified the Stockholm Convention on January 13, 2006 as per Article 25(4), which enabled it to keep itself in a default "optout" position such that amendments in various Annexes of the convention cannot be enforced on it unless an instrument of ratification/acceptance/approval or accession is explicitly deposited with UN depositary.
- Considering its commitment towards providing safe environment and addressing human health risks, the Ministry of Environment, Forest and Climate Change (MoEFCC) had notified the 'Regulation of Persistent Organic Pollutants Rules, on March 5, 2018 under the provisions of Environment (Protection) Act, 1986.
- The regulation inter alia prohibited the manufacture, trade, use, import and export seven chemicals namely
- 1. Chlordecone
- 2. Hexabromobiphenyl
- 3. Hexabromodiphenyl ether and Heptabromodiphenylether (Commercial octa-BDE)



- 4. Tetrabromodiphenyl ether and Pentabromodiphenyl ether (Commercial penta-BDE)
- 5. Pentachlorobenzene
- 6. Hexabromocyclododecane
- 7. Hexachlorobutadiene
- These seven chemicals were already listed as POPs under Stockholm Convention.
- The ratification process would enable India to access Global Environment Facility (GEF) financial resources in updating the NIP.
- The Cabinet further delegated its powers to ratify chemicals under the Stockholm Convention to Union Ministers of External Affairs (MEA) and Environment, Forest and Climate Change (MEFCC) in respect of POPs already regulated under the domestic regulations thereby streamlining the procedure.

• Union Minister for Science & Technology has inaugurated the "DBT-BIRAC Clean Tech Demo Park" at Barapullah drain site, near Sundial Park, Sarai Kale Khan, New Delhi in a virtual event recently.

### DBT-BIRAC Clean Tech Demo Park

- It will be used to demonstrate innovative Waste-to-Value technologies with support from Department of Biotechnology (DBT), Government of India, and Biotechnology Industry Research Assistance Council (BIRAC), a DBT PSU.

 Technologies developed by Startups at different locations in the Country will be demonstrated on this site.

- BARC India is a Joint Industry Company founded by stakeholder bodies that represent Broadcasters, Advertisers, and Advertising and Media Agencies.

- Japan, South Korea and UAE are the only other Asian nations who have been conferred with a couple of Blue Flag beaches, however, in a time frame of about 5 to 6 years.
- India is now in the league of 50 "BLUE FLAG" countries.

# Background

- India began its humble journey in 2018 for development of pilot beaches (one each in coastal states/UTs) and presented the first set of 08 beaches for the certification for the ensuing tourist season 2020.
- SICOM, MoEFCC, in its pursuit of "Sustainable Development" of the coastal regions of India embarked upon a highly acclaimed & flagship program "BEAMS" (Beach Environment & Aesthetics Management Services) under its ICZM (Integrated Coastal Zone Management) project.
- This was aimed at striving for the coveted International eco-label "Blue flag", accorded by The Foundation of Environment Education, FEE Denmark.
- The objective of the BEAMS program is to abate pollution in coastal waters & beaches, promote sustainable development of beach amenities/ facilities, protect & conserve coastal ecosystems & natural resources and encourage local authorities & stakeholders to strive and maintain high standards of cleanliness, hygiene, safety and security for beachgoers in accordance with coastal environment norms & regulations.
- This program promotes beach tourism and recreation in absolute harmony with nature; and is unique in that sense.

### SVAMITVA Scheme

- It aims at the holistic development of tribals focus with entrepreneurship a on development, soft skills, IT, and business development through **SHGs** operating through *Van* Dhan Vikas Kendras (VDVKs).
- The beneficiaries will undergo a 30 days program over six weeks comprising 120 sessions.
- The programme aims to tap the traditional knowledge and skills of tribals and add branding, packaging and marketing skills to optimize their income through a market led enterprise model by setting up of Van Dhan Kendras (VDVKs).
- TRIFED has so far sanctioned 1243 Van Dhan Kendras in 21 States and 1 UT involving 3.68 lakh tribal gatherers.

- Notice so published is also displayed on the website of the Commission.

- After Independence, Lohia founded an organisation called Hind Kisan Panchayat to help farmers with agricultural solutions.
- He had also protested against the Portuguese government's policy of restricted speech and movement of natives in Goa.
- Lohia made Hindi the official language of India after Independence. He had said, "The use of English is a hindrance to original thinking, progenitor of inferiority feelings and a gap between the educated and uneducated public. Come, let us unite to restore Hindi to its original glory."
- Lohia is also famous for his remark against the then Prime Minister Jawaharlal Nehru.
- He wrote a pamphlet named '25000 rupees in a day' where he had said that the amount of money spent on the Prime Minister for a single day is much more than the poor country could afford.

- It aims to ensure that safety data generated on various chemicals like industrial chemicals, pharmaceuticals (Human and Veterinary), agrochemicals, cosmetic products, food/ feed additives, and medical devices, etc., can be relied upon by regulatory authorities.
- India has been designated the 'Vice-Chair' of Good Laboratory Practice (GLP) Working Group of the OECD, recognising the contribution of the Indian GLP programme.
- The Department of Science and Technology (DST), Government of India, established the *National GLP Compliance Monitoring Authority (NGCMA)* with the approval of the Union Cabinet on April 24, 2002.

- NGCMA is the National body which grants GLP certification to test facilities (TFs) conducting safety studies on new chemicals of the above-mentioned categories in accordance with OECD Principles of GLP and OECD Council norms.
- The non-hazardous nature of chemicals needs to be established through studies and data, which is examined by the regulators of the concerned countries to certify that the use of these chemicals does not pose any hazards to human health and the environment.

• **Rhine** is one of the major European rivers, which has its sources in **Switzerland** and flows in a mostly northerly direction through **Germany and the Netherlands**, emptying into the **North Sea**.

# Banda Singh Bahadur (1670-1716)

- The name of Mukhlisgarh was changed to Lohgarh (Fort of Steel), and it became the capital of the first Sikh state.
- Banda Singh Bahadur abolished the zamindari system in Punjab.

Sciences (2020) category Prof. Rajesh Ganapathy from Jawaharlal Nehru Centre for Advanced Scientific Research has observed glass made of colloidal particles and monitored their dynamics over several days.

## Devitrification

- *Glass* is a non-crystalline, often transparent amorphous solid which is mostly formed by rapid cooling of its molten form.
- However, under certain conditions, during its formation, molten glass may rebel and transform to a crystal the more stable state, an avoidable process called *devitrification*.
- However, the process of devitrification remains poorly understood as this process can be extremely slow, and this makes it difficult to study it.
- Scientists have now **visualized devitrification in an experiment**, thus taking a step closer to understanding it.
- This could help avoid devitrification in processes of pharma industries – a sector in which dodging this is of paramount importance.
- This is because an amorphous drug dissolves faster than after devitrification, and ensuring that it remains amorphous is therefore essential during storage.
- The experiment can also help in vitrification of liquid nuclear waste as a solid in a glass matrix to safely dispose it deep underground and prevent hazardous materials from leaking into the environment.

- CSIR-Institute of Himalayan Bio-resource Technology (IHBT), makes history by introducing asafoetida (Heeng) cultivation in Indian Himalayan region.
- The first seedling of asafoetida was planted by Dr. Sanjay Kumar, Director, CSIR-IHBT on 15th October, 2020 at farmer's field in village Kwaring of Lahaul valley to mark initiation of cultivation of asafoetida in India.

#### Asafoetida

- It is one of the top condiments and is a high value spice crop in India.
- India *imports about 1200 tonnes of raw* asafoetida annually from Afghanistan, Iran and Uzbekistan and spends approximately 100 million USD per year.
- Lack of planting material of Ferula assafoetida plants in India was a major bottleneck in cultivation of this crop.
- The plant prefers cold and dry conditions for its growth and takes approximately five years for the production of oleo-gum resin in its roots, therefore cold desert areas of Indian Himalayan region are suitable for cultivation of asafoetida.



- Raw asafoetida is extracted from the fleshy roots of Ferula assa-foetida as an oleo-gum resin.
- Although, there are about 130 species of Ferula found in the world, but only Ferula assafoetida is the economically important species used for the production of asafoetida.
- In India, we do not have Ferula assa-foetida, but other species Ferula jaeschkeana is reported from the western Himalaya (Chamba, HP), and Ferula narthex from Kashmir and Ladakh, which are not the species that yield asafoetida.

- Union Minister for Road Transport and Highways Shri Nitin Gadkari has virtually laid the foundation stone for the first-ever multi-modal logistic park in Assam recently.

- The scheme covers establishment, modernization, expansion, repairs, renovation of hospital and healthcare and education infrastructure.
- NCDC assistance will flow either through the State Governments/ UT Administrations or directly to the eligible cooperatives.

- The scheme also provides working capital and margin money to meet operational requirements.
- Further, the scheme provides interest subvention of 1% to women majority cooperatives.

- NTPC Dadri is striving to become the cleanest coal fired plant in the country and is complying with all the CPCB guidelines on emissions.
- NTPC Ltd is a Public Sector Undertaking (PSU) under Ministry of Power.

### Highlights of the plant

- The Flue gas emissions and Particulate matter are well within the CPCB norms with high efficiency ESP (Electrostatic Precipitators) in service in all the 210 MW & 490 MW units.
- For SOx reduction, Dry Sorbent Injection (DSI) system has been installed.
- SOFA (Separated Over fire Air) system has been installed for NOx emission.
- It has also pioneered **co-firing of Biomass pellets along with coal** in the boilers.
- The pellets are made of husk or agro-residue which would have been burnt otherwise in the fields increasing the pollution in NCR region.
- More than 8000 Tons of pellets have been fired in the boilers of NTPC Dadri, which is equivalent to almost 4000 acres of farm fire avoided.
- NTPC Dadri has set new benchmarks in Water consumption, going beyond compliances, by implementing Zero liquid discharge system, and Rain water harvesting system.

   solution for Vessel traffic services (VTS) and
   Vessels Traffic Monitoring Systems (VTMS) in
   New Delhi.
- VTS and VTMS software will pave the way for 'Make for the world' vessel traffic management systems.
- VTS and VTMS is a software which determines vessel positions, position of other traffic or meteorological hazard warnings and extensive management of traffic within a port or waterway.
- Ministry of Shipping has sanctioned an amount of Rs. 10 Crore to IIT, Chennai for development of indigenous VTS software.

#### Vessel Traffic Services (VTS)

• It contribute to safety of life at sea, safety and efficiency of navigation and protection of the marine environment, adjacent shore areas, work sites and offshore installations from possible adverse effects of maritime traffic.

### Vessels Traffic Management Systems (VTMS)

- They are installed in some of the busiest waters in the world, and are making valuable contribution to safer navigation, more efficient traffic flow, and protection of the environment.
- Traffic flow in busy approach routes, access channels, and harbours can be coordinated safely, in the best interest of port and its users.
- VTMS is mandatory under IMO Convention SOLAS (Safety of Life at Sea).

#### **Background**

 Presently, India has approximately 15 VTS systems operational along the Indian Coast

- and there is no uniformity of VTS software as each system has its own VTS software.
- With the indigenous software development in progress the recent positive cooperation with office of Director General of Light and Lighthouses (DGLL) on joint development of the indigenous VTMS software development as part of the Aatmanirbhar Bharat initiative will strengthen the cooperation in this area.

Accordingly, indigenous development of VTS software will benefit in:

- Saving of foreign exchange for various VTSs in India.
- 2. VTS Software can be provided to Indian trade friendly nations viz. Maldives, Mauritius, Myanmar, Sri Lanka, Mauritius, Bangladesh and Gulf countries.
- 3. Will also minimize the cost for future upgradations of software.
- 4. Shall be easier to interconnect with MIS/ERP softwares of ports.
- 5. Availability of Indian VTS software shall make Indian companies to be competitive commercially in global bids.
- 6. Implementation of National Maritime Domain Awareness programme of Indian Navy and NCVTS by DGLL a real time, interactive aids to navigation system for coastal shipping shall become feasible with Indian VTS software at low cost.

#### 2. d

- The 6th edition of India International Science Festival (IISF) 2020 will be held from 22ndto 25th December, 2020.

### **India International Science Festival (IISF)**

- The first and second IISF were held in New Delhi, the third in Chennai, the fourth in Lucknow, and the fifth IISF was held in Kolkata.

- Union Minister for Science & Technology has recently inaugurated the Di-Methyl Ether (DME) fired 'Aditi Urja Sanch' unit along with the DME-LPG blended fuel cylinders and handed them over for common public and CSIR-NCL (National Chemical Laboratory) canteen use on a trial basis at CSIR-NCL premises.
- CSIR-NCL has also developed nation's first kind of DME pilot plant with 20-24Kg/day capacity.

#### Aditi Urja Sanch

- It is a Dimethyl ether (DME) fired stove.
- DME is an ultra-clean fuel.
- The conventional LPG burner is not suitable for DME combustion as DME density is different than LPG.
- To address this issue, CSIR- NCL's Aditi Urja Sanch has come up with a helpful, innovative setup.
- The new Burner is fully designed and fabricated by CSIR-NCL for DME, DME -LPG blended mixtures and LPG combustion.
- Trial runs have demonstrated an improvement by 10-15%, compared to conventional burners using LPG alone.
- A clean cooking fuel combination of DME-LPG also safeguards the well-being of women and children.
- The newly designed stove can burn with up to 30 % DME blended with LPG or 100% DME as fuel.

• The launch of this burner will also provide a significant boost to the 'Make in India' campaign as all the manufacturers of cylinders, gas stoves, regulators, and gas hose are domestic.

• Election Commission has recently constituted a committee headed by Sh. Harish Kumar, Ex. IRS and DG (Investigation) comprising Sh. Umesh Sinha, Secretary General and DG (Expenditure) to examine the issues concerning expenditure limit for a candidate in view of increase in number of electors and rise in Cost Inflation Index and other factors.

## Background

- Considering the factor of COVID-19, the Ministry of Law & Justice on 19.10.2020 has notified an amendment in Rule 90 of Conduct of Elections Rules, 1961 enhancing the existing expenditure limit by 10%.
- This increase of 10% will be applicable with immediate effect in ongoing elections.
- Expenditure limit for a candidate was last revised in 2014, while in respect of Andhra Pradesh and Telangana it was revised in 2018.
- In last 6 years the limit was not increased despite increase in electorate from 834 million to 910 million in 2019 to 921 million now.
- Further, Cost Inflation Index during this period has increased from 220 to 280 in 2019 to 301 now.

The committee will have following terms of reference:-

- 1. To assess the change in number of electors across the States/Union Territories and its bearing on expenditure.
- 2. To assess the change in Cost Inflation Index and its bearing on the pattern of expenditure incurred by the candidates in recent elections.
- 3. To seek views/inputs of the political parties and other stakeholders.
- 4. To examine other factors which may have bearings on expenditure.
- 5. To examine any other related issue.
- The Committee will submit its report within 120 days of its constitution.

 Union Minister of State for Culture and Tourism (IC), Shri Prahlad Singh Patel attended Commemoration of 77th Year of Formation of Azad Hind Government recently at Red Fort, Delhi.

## **Azad Hind Government**

• On October 21, 1943, Netaji Subash Chandra Bose announced the formation of the Provisional Government of Free India (PGFI), Arzi Hakumat-e-Azad Hind, or, in short, Azad Hind Government, an Indian government-in-exile.

- Bose was convinced that it was armed struggle that would help the countrymen to achieve independence.
- The leadership of Bose pulled Indians, who united with thousands of soldiers, along with former-prisoners and other expatriates who were living in Malayasia and Burma.
- Under the provisional Government, Bose was the Head of State, Prime Minister and Minister of War.
- Captain Lakshmi headed the women's organisation while SA Ayer headed the publicity wing in the newly-formed government.
- Revolutionary leader Ras Behari Bose was designated as the supreme adviser by Netaji Subhash Chandra Bose.
- The government was supported by the Axis powers of Imperial Japan, Nazi Germany, the Italian Social Republic, and their allies.
- It started functioning from Singapore with 11 ministers and eight representatives from the INA.
- The PGFI was a culmination of the political movement originating in the early 1940's outside India with the purpose to liberate her from the British rule.
- The government of Azad Hind soon had its own currency, court, civil code and national anthem 'Subh Sukh Chain'.
- The INA had its motto, 'Ittehad, Itmad aur Qurbani' (unity, faith and sacrifice) and its national greeting 'Jai Hind'.
- Its existence gave greater legitimacy to the independence struggle.
- Immediately after the formation of the government-in-exile, Azad Hind declared war against the Britishers and allied forces on the Indo-Burma Front.

2. b

- The Labour and Employment Ministry has recently revised the base year of the Consumer Price Index for Industrial Workers (CPI-IW) from 2001 to 2016.
- It aims to reflect the changing consumption pattern, giving more weightage to spending on



health, education, recreation and other miscellaneous expenses, while **reducing the weight of food and beverages**.

#### CPI-IW

- It is the single most important price statistics, which has financial implications.
- Labour Bureau, an attached office of Ministry of Labour & Employment, has been compiling and releasing CPI-IW numbers since its inception in 1946.
- Earlier to this revision, the series were also revised from the year 1944 to 1949; 1949 to 1960; 1960 to 1982 and 1982 to 2001 since inception of Labour Bureau.
- It is primarily used to regulate the dearness allowance of government employees and the workers in the industrial sectors.
- It is also used in fixation and revision of minimum wages in scheduled employments besides measuring the inflation in retail prices.

- INS Kavaratti (P31), Anti-Submarine Warfare (ASW) stealth corvette built under Project 28 (Kamorta Class) was recently commissioned into the Indian Navy by General Manoj Mukund Naravane, Chief of the Army Staff at a ceremony held at Naval Dockyard, Visakhapatnam.
- It has been named after the capital of the Lakshadweep group of islands.
- The ship is propelled by four Diesel engines.
- The ship has enhanced stealth features resulting in reduced Radar Cross Section (RCS) achieved by X form of superstructure along with optimally sloped surfaces.
- The ship's advanced stealth features make her less susceptible to detection by the enemy.
- The unique feature of this ship is the **high level of indigenisation** incorporated in the production, accentuating our National Objective of 'Atmanirbhar Bharat'.
- The ship has high indigenous content with the state of the art equipment & systems to fight in Nuclear, Biological and Chemical (NBC) warfare conditions.

- Also, the weapons and sensors suite onboard is pre-dominantly indigenous and showcases the Nation's evolving capability in this niche area.
- Some of the major equipment/systems developed indigenously include Combat Management System, Torpedo Tube Launchers and Infra-Red Signature Suppression System etc.
- The ship is the reincarnation of the erstwhile Arnala Class missile corvette of the same name (INS Kavaratti P 80).

- In order to provide further relief to the taxpayers desirous of settling disputes under Vivad se Vishwas Scheme, the Government has recently further extended the date for making payment without additional amount from 31st December 2020 to 31st March 2021.
- The last date for making declaration under the Scheme has also been notified as 31st December 2020.

### Vivad se Vishwas scheme

- It is a direct tax scheme announced in Budget 2020, for settling tax disputes between individuals and the income tax department.
- The Direct Tax Vivad se Vishwas Act, 2020 was enacted on 17th March, 2020 with the objective:
- 1. To reduce pending income tax litigation
- 2. To generate timely revenue for the Government
- 3. To benefit taxpayers by providing them peace of mind, certainty and savings on account of time and resources that would otherwise be spent on the long-drawn and vexatious litigation process.
- Earlier, the scheme offered complete waiver on interest and penalty to the taxpayers with a full and final settlement of the dispute if the scheme was availed by March 31, 2020.
- An individual opting for settlement after March 31, 2020 was required to pay additional 10 per cent penalty on the disputed tax amount.
- It was later extended to 30th June, 2020. Later again, this date was extended further to 31st December, 2020.

• A group of Scientists from Wadia Institute of Himalayan Geology (WIHG), Dehradun, an autonomous institute under the Department of Science and Technology, Government of India, have found through observations and detailed mapping of geological features that the suture zone of Himalaya that was conventionally thought to be locked is tectonically active.

### Indus Suture Zone (ISZ)

- The suture zone of the Himalayas or the Indus Suture Zone (ISZ) is located in the Ladakh region where Indian and Asian Plates are joined.
- It has been found to be tectonically active, as against current understanding that it is a locked zone.
- This could have major implications in terms of earthquake study, prediction, understanding the seismic structure of the mountain chains well as its evolution.
- Himalaya were known to be made up of north dipping thrusts like the Main Central Thrust (MCT), the Main Boundary Thrust (MBT), and the Main Frontal Thrust (MFT).
- As per the established models, all of these thrusts except MFT are locked, and overall deformation in Himalaya is being accommodated only along with the MFT.
- The new findings, which suggest a more remote fault at the suture zone being neotectonically active, could call for a serious relook into the existing evolutionary models using new techniques and a larger geological database.

3. b

- Researchers from the Netherlands Cancer Institute have recently discovered two "unexpected" areas in the back of the nasopharynx.
- When researchers were studying scans from about 100 people, they found a bilateral structure at the back of the nasopharynx and these glands had similar characteristics of salivary glands.

### Salivary Gland Systems

- These are part of exocrine gland systems of Human Body.
- The salivary gland system in the human body has **three paired major glands** and over 1,000 minor glands that are spread throughout the mucosa.
- The three major salivary glands are called *parotid*, *submandibular* and *sublingual*.



- These glands produce saliva necessary for swallowing, digestion, tasting, mastication and dental hygiene.
- Researchers have proposed the name "tubarial glands" for their discovery.
- The proposed name is based on their anatomical location.
- Even so, it is not clear yet if these glands will be classified as a conglomerate of minor glands, as a major gland, a separate organ or a new part of an organ system.
- The researchers believe that these glands would qualify as the fourth pair of major salivary glands.
- The researchers believed that the new location of salivary glands will be a good news for patients with head and neck tumours as radiation oncologists will be able to bypass this area to avoid any complications during treatment.

• The Basic Exchange and Cooperation Agreement for Geo-Spatial Cooperation or BECA, long in the making, has finally been signed by India and the US recently.

# Basic Exchange and Cooperation Agreement (BECA)

- It is the last of the pacts that America signs with close partners.
- It is essentially a communication agreement proposed between the National Geospatial-Intelligence Agency of the US Department of Defence and the Ministry of Defence of the Government of India.
- It will allow India and the US to share military information including advanced satellite and topographic data such as maps, nautical and aeronautical charts and geodetic, geophysical, geomagnetic and gravity data.
- Most of the information shared will be unclassified.
- However, the pact includes a provision of sharing classified information with safeguards to prevent it from being shared with any third party.

- Supplemented by highly accurate US satellites, this geospatial information can help in navigation and, more importantly, in targeting military assets.
- India and the US have already signed three key foundational agreements General Security of Military Information Agreement (GSOMIA) in 2002, the Logistics Exchange Memorandum of Agreement (LEMOA) in 2016 and Communications Compatibility and Security Agreement (COMCASA) in 2018.
- LEMOA gives access, to both countries, to designated military facilities on either side for the purpose of refuelling and replenishment.

- Recently, Kabartal Wetland (Bihar) and Asan Conservation Reserve (Uttrakhand) have been designated as Ramsar sites.
- Earlier in 2020, India designated 10 more wetlands as a Ramsar site, taking the total number from 27 to 37.
- With 2 more inclusions, the total number of Ramsar sites in India is 39, the highest in South Asia.

### Kabartal Wetland

- It is known as Kanwar Jheel, it covers 2,620 hectares of the Indo-Gangetic plains in the Begusarai district of Bihar.
- It acts as a vital flood buffer for the region besides providing livelihood opportunities to local communities.
- It is also a valuable site for fish biodiversity with over 50 species documented.
- It is an important stopover along the Central Asian Flyway, with 58 migratory waterbirds using it to rest and refuel.
- Five critically endangered species inhabit the site, including three vultures the red-headed vulture (Sarcogyps calvus), white-rumped vulture (Gyps bengalensis) and Indian vulture (Gyps indicus) and two waterbirds, the sociable lapwing (Vanellus gregarius) and Baer's pochard (Aythya baeri).

#### **Asan Conservation Reserve**

• ACR is a 444-hectare stretch of the Asan River running down to its confluence with the



Yamuna River in Dehradun district of Uttarakhand.

- It is Uttarakhand's first Ramsar Site.
- The damming of the River by the Asan Barrage in 1967 resulted in siltation above the dam wall, which helped to create some of the Site's bird-friendly habitats.
- These habitats support 330 species of birds including the critically endangered red-headed vulture (Sarcogyps calvus), white-rumped vulture (Gyps bengalensis) and Baer's pochard (Aythya baeri).
- Other non-avian species present include 49 fish species, one of these being the endangered Putitora mahseer (Tor putitora).

- The loan proceeds will be utilised by NTPC for funding its capital expenditure for flue-gas desulphurisation (FGD) and renewable energy projects.
- The facility is extended under JBIC's outreach for projects that ensure conservation of the global environment.
- FGD is expected to substantially reduce sulphur emissions in the flue gases of thermal power plants and is a critical step towards environmental sustainability.

- It is the United Nations agency for the world of work.

- The ILO has a unique structure, bringing together governments, employers' and workers' representatives.
- The ILO has 187 member States and is one of the oldest UN agencies.
- The ILO's Secretariat has its headquarters in Geneva, Switzerland, and a global network of technical experts and field offices in more than 40 countries.
- The International Labour Conference (ILC) meets once a year to adopt new international labour standards and to approve the ILO's work plan and budget.

• The Governing Body is the executive council of the ILO and meets three times a year in Geneva.

- The ILO is founded as part of the Treaty of Versailles that ended the First World War, 1919, to reflect the belief that universal and lasting peace cannot be achieved without social justice.
- The ILO becomes the first specialized agency of the United Nations in 1946.
- The Organization is awarded the Nobel Peace Prize in 1969.

### Kisan Suryodaya Yojana



- Kisan Suryodaya is scheme of Gujarat state government.
- It is aimed at providing day-time electricity to farmers in Gujarat for irrigation and farming purposes.

- Micro irrigation is defined as the frequent application of small quantities of water directly above and below the soil surface; usually as discrete drops, continuous drops or tiny streams through emitters placed along a water delivery line.

- NITI Aayog, Ministry of Power, Rockefeller Foundation and Smart Power India have recently launched the 'Electricity Access in India and Benchmarking Distribution Utilities' report.
- The report is based on a primary survey conducted across ten states, representing about 65 per cent of the total rural population of India and with a sample size of more than 25 thousand, including households, commercial enterprises and institutions.
- According to the report, 92 per cent of customers reported the overall availability of electricity infrastructure within 50 metres of their premises.
- 87 per cent of the surveyed customers have access to grid-based electricity. The remaining 13 per cent either use non-grid sources or do not use any electricity at all.

- The hours of supply have improved significantly across the customer categories to nearly 17 hours per day.
- The report underlines some best practices adopted by the better-performing electricity distribution utilities in India and provides key recommendations to enhance sustainable electricity access.
- The data from the survey provides evidence that the infrastructure of providing electricity across sectors has improved over time.
- It also shows that reforms undertaken by the Government have been appreciated by the stakeholders.

- Indian Railways has recently launched "Meri Saheli" initiative for focused action on security of women across all zones with an objective to provide safety and security to lady passengers travelling by trains for their entire journey from starting station to destination station.
- An initiative of RPF, the Strategy of the entails interaction with lady passengers especially those travelling alone by a team of young lady RPF personnel at the originating station.
- These lady passengers are briefed about all precautions to be taken during the journey and told to dial 182 in case they face or see any problem in the coach.
- The RPF team collects only the seat numbers of the ladies and conveys them to stoppages en-route.
- The platform duty RPF personnel at the stopping stations en-route keep unobtrusive watch over the concerned coaches and berths and if need arises, interact with the lady passengers.
- RPF/RPSF escort onboard also covers all the coaches/identified berths during its duty period.
- RPF teams at the destination collect the feedback from the identified lady passengers.
- The feedback is then analysed and corrective action, if any, is taken.
- If some distress call comes from a train covered under "Meri Saheli" initiative, the disposal of the call is monitored at the level of senior officers.
- The "Meri Saheli" initiative was started as a pilot project in South Eastern Railway in September 2020 and after getting encouraging response from lady passengers, it was extended to all zones and KRCL w.e.f. 17.10.2020.

2. d

 The Cabinet Committee on Economic Affairs chaired by the Prime Minister Shri Narendra Modi has recently approved that 100% of the



food grains and 20% of the sugar shall be mandatorily packed in diversified jute bags.

- The decision to pack sugar in diversified jute bags will give an impetus to the diversification of the jute industry.
- Further, the decision also mandates that initially 10% of the indents of jute bags for packing food grains would be placed through reverse auction on the GeM portal.
- This will gradually usher in a regime of price discovery.
- The Government has expanded the scope of mandatory packaging norms under the Jute Packaging Material (JPM) Act, 1987.

#### Jute

- It is soft, flexible and hard-wearing bast fibre.
- Jute fibres are long, lustrous, resilient and softer to touch.
- It has a natural colour in light tan to brown range and its fibre can be bleached and can be dyed well.

### Distribution of Jute Cultivation

- The cultivation of jute in India is mainly confined to the eastern region of the country.
- The jute crop is grown in nearly 83 districts of seven states - West Bengal, Assam, Orissa, Bihar, Uttar Pradesh, Tripura and Meghalaya.
- West Bengal alone accounts for over 50 percent raw jute production.
- The leading world's jute producing countries are India, Bangladesh, China and Thailand.
- India is the world's largest producer of raw jute and jute goods, contributing to over 50 percent and 40 percent respectively of global production.

### Requirements

- Jute crop requires humid climate with temperature fluctuating between 24 degree Celsius and 38 degree Celsius.
- Minimum rainfall required for jute cultivation is 1000 mm.
- New grey alluvial soil of good depth receiving silt from annual floods is most suitable for jute growth.

• However, jute is grown widely in sandy looms and clay loams.

#### **Jute Cultivation**

- Jute is generally sown during March to May depending on the nature of land and atmospheric condition.
- About 90 to 100 days after sowing and jute plants attain desired length from 8 to 12 feet high , are cut with stickles close to the ground
- The stems are then made into bundles and left on field for 3 to 4 days.
- These bundles are then steeped in water for retting for, about 3 weeks.
- During this period, fibres get loose from the stem of the plant and are separated manually. These fibres are washed thoroughly in clean water, dried under sun and made into bundles.

• The Ministry of Shipping has drafted a Coastal Shipping Bill, 2020 in lieu of part XIV of the Merchant Shipping Act, 1958.

Some of the highlights of the Bill are as under:

- The definition of coastal shipping and coastal waters has been expanded.

 The Science and Engineering Research Board (SERB), a Statutory body of the Department of Science and Technology (DST), Government of India, has been contemplating to institute a scheme to mitigate gender disparity in science and engineering research in various S&T



programs in Indian academic institutions and R&D laboratories.

- Dr. Harsh Vardhan, Union Minister for Science & Technology, Earth Sciences and Health & Family Welfare has recently launched a Scheme titled "SERB-POWER (Promoting Opportunities for Women in Exploratory Research).
- The scheme was designed exclusively for women scientists.

SERB – POWER Scheme will have two components namely

- 1. SERB-POWER Fellowship
- 2. SERB- POWER Research Grants.

The salient features of each of these are as follows:

### Salient features of the **SERB-POWER Fellowship**:-

- 1. Target: Women researchers in 35-55 years of age. Up-to 25 Fellowships per year and not more than 75 at any point in time.
- 2. Components of support: Fellowship of Rs. 15,000/- per month in addition to regular income; Research grant of Rs. 10 lakh per annum; and Overhead of Rs. 90,000/- per annum.
- 3. Duration: Three years, without the possibility of extension. Once in a career.

# Salient features of the **SERB – POWER Research Grants**:

- 1. POWER Grants will empower women researchers by funding them under following two categories:
- 1. Level I (Applicants from IITs, IISERs, IISc, NITs, Central Universities, and National Labs of Central Government Institutions): The scale of funding is up to 60 lakhs for three years.
- 2. Level II (Applicants from State Universities / Colleges and Private Academic Institutions): The scale of funding is up to 30 lakhs for three years.
- POWER Grant will be regulated through terms of reference conforming to SERB-CRG(Science and Engineering Research Board-Core Research Grant) guidelines.
- While a Search-cum-Selection Committee constituted for the purpose will help in identifying the POWER Fellowship, the

existing Programme Advisory Committee (PAC) mechanism will be used to select the POWER Research Grants.

- It is proposed to institute 25 POWER Fellowships annually.
- A total of 50 Power Grants each will be sanctioned in Level I & Level II per annum.

5. d

- In the quest for 'Atmanirbhar Bharat', *Indian Army* has developed a simple and secure *messaging application* named the "Secure Application for Internet (SAI)".
- The application supports end to end secure voice, text and video calling services for Android platform over internet.

#### **Answers**

- Recently Union government has notified 'Union Territory of Jammu and Kashmir Reorganisation (Adaptation of Central Laws) Third Order, 2020.
- It states that any Indian citizen can now buy land in Jammu and Kashmir (J&K) without being a domicile.
- The introduction of the UT of J&K Reorganisation (Adaptation of Central Laws) Third Order, 2020 has resulted in the repeal of at least 11 land laws in J&K, including the J&K Big Landed Estates Abolition Act that had resulted in famous 'Land to tiller' rights.

#### The features of the latest order are as follows

- 1. No domicile or permanent resident certificate is required to purchase non-agricultural land in the UT.
- 2. People as well as investors outside J&K can now purchase land in the UT, ending the exclusive rights of locals over the land granted under Article 370 (now abrogated).
- 3. The Centre also notified the Real Estate (Regulation and Development) Act, 2016, which paves the way for the acquisition of land in J&K by all Indian citizens.
- 4. The amendment has Abolished the Big Land Estate Abolition Act, 1950 this provided for redistribution of land which paved the way for rural prosperity and ended landlordism in J&K.
- 5. Empowers the Centre to declare any area in J&K as 'strategic' and intended for the direct



- operational and training requirement of the armed forces.
- 6. However, this can be only done by an army officer of or above the rank of a corps commander.
- Spouses of a J&K domicile shall also be deemed as a domicile, earlier, spouses of domiciles were not considered domiciles.
- 8. Children of central government officials posted for over ten years in J&K will also continue to be considered domiciles.

2. b

 A strong earthquake struck in the Aegean Sea between the Turkish coast and the Greek island of Samos, killing at least 14 people and injuring hundreds amid collapsed buildings and flooding.

### Aegean Sea

- Aegean Sea is an arm of the Mediterranean Sea, located between the Greek peninsula on the west and Asia Minor on the east.
- Asia Minor also called as Anatolia, the peninsula of land that today constitutes the Asian portion of Turkey.
- The Aegean is connected through the straits of the Dardanelles, the Sea of Marmara, and the Bosporus to the Black Sea, while the island of Crete can be taken as marking its boundary on the south.

- The President of India has recently signed The Commission for Air Quality Management in National Capital Region and Adjoining Areas Ordinance, 2020.
- The Ordinance seeks to create an overarching body to consolidate all monitoring bodies, and to bring them on one platform so air quality management can be carried out in a more comprehensive, efficient, and time-bound manner.
- The Centre also seeks to relieve the Supreme Court from having to constantly monitor pollution levels through various pollutionrelated cases.

### Compostition

- The Commission, which will be a permanent body, will have over 20 members, and will be chaired by a retired official of the level of Secretary to the Government of India or Chief Secretary of a state.
- It will include a representative of the Secretary of the MoEF, five Secretary level officers who will be ex officio members, and two joint secretary level officers who will be full-time members.
- The Commission will also have representation from the CPCB, ISRO, air pollution experts, and three representatives of non-government organisations (NGOs).
- As associate members, the Commission will have representatives from various other Ministries including the Ministries of Agriculture, Petroleum, Power, Road Transport and Highways, Housing and Urban Affairs, and Commerce and Industry.

### **Powers of the Commission**

- In matters of air pollution and air quality management, the Commission will supersede all existing bodies such as the CPCB, and even the state governments of Haryana, Punjab, Rajasthan, and Uttar Pradesh.
- It will have the powers to issue directions to the states.
- The Central Pollution Control Board and its State branches have the powers to implement provisions of the Environment (Protection) Act for air, water and land pollution.
- In case of dispute or a clash of jurisdictions, the commission's writ will prevail specific to matters concerning air pollution.
- The Commission will also coordinate efforts of state governments to curb air pollution, and will lay down the parameters of air quality for the region.
- It will have powers to restrict the setting up of industries in vulnerable areas, and will be able to conduct site inspections of industrial units.
- If its directions are contravened, through say, the setting up of an industrial unit in a restricted area, the Commission will have the



power to impose a fine of up to Rs 1 crore and imprisonment of up to 5 years.

#### 4. c

- The Centre has recently notified 9.8 km around the boundaries of the Silent Valley National Park as an eco-sensitive zone.
- A notification issued recently says that 148 sq km area will be eco-sensitive and several new restrictions on human activities will be imposed in the area.

### Silent Valley National Park

- It is one of the most popular biodervisity-rich forests in the country.
- A large part of Silent Valley still remains untouched by human beings.
- It has a large variety of flora and fauna.
- As many as 17 species of its flora had been redlisted by the International Union for Conservation of Nature (IUCN).
- The main basin of the perennial river Kunthipuzha, which runs from north to south and empties its waters into the Bharathapuzha, is covered by these forests.
- Anginda Peak (2,383 m) is the highest peak in the Silent Valley National Park.
- The indigenous tribal groups that live within park boundaries include Irulas, Kurumbas, Mudugas and Kattunaikkars, the ethnic heritage of these communities is well protected.

### 5. d

- Kerala was adjudged the best governed State in the large States category, while Uttar Pradesh ended at the bottom in the Public Affairs Index-2020 released by the Public Affairs Centre recently.
- Public Affairs Centre is a New Delhi based notfor-profit organization.
- It was headed by former Indian Space Research Organisation (ISRO) Chairman K. Kasturirangan.

# Highlights

 According to the PAC, the governance performance is analysed in the context of

- sustainable development defined by the three pillars of equity, growth and sustainability.
- Four southern States Kerala (1.388 PAI Index point), Tamil Nadu (0.912), Andhra Pradesh (0.531) and Karnataka (0.468) stood in the first four ranks in the large State category in terms of governance.
- Uttar Pradesh (-1.461), Odisha (-1.201) and Bihar (-1.158) were at the bottom of the ranking.
- In the small State category, Goa ranked first with 1.745 points, followed by Meghalaya (0.797) and Himachal Pradesh (0.725).
- The worst performers in the index with negative points were Manipur (-0.363), Delhi (-0.289) and Uttarakhand (-0.277).
- Chandigarh emerged at the top in the category of Union Territories with 1.05 PAI points, followed by Puducherry (0.52) and Lakshadweep (0.003).
- Dadar and Nagar Haveli (-0.69), Andaman, Jammu and Kashmir (-0.50) and Nicobar (-0.30) were the worst performers.
